Cllr R Huffer attended the meeting and reported on Shropshire Council matters referring to Climate change and the condition of the highways.

2. Minutes:

The Minutes of the Parish Council meeting held on the 18th November 2019 were approved and signed by the Chairman as a correct record.

3. Matters arising from the minutes not included on the agenda:

Mr A Pryor enquired if there had been any progress on suggested road safety improvement along Tenbury Road Clee Hill, the Clerk reported that this was currently being considered by a working group at Shropshire Council along with other suggested schemes in Shropshire.

4. Chairman's Communications:

The Clerk read a letter received from the President of the Shropshire Association of Parish and Town Councils congratulating him on his 43 years-service as a Parish Clerk.

6. Highway/Amenity Items:

- a) The Clerk reported on the transfer of the Amenity Land, roadway and footpath at Sycamore Grove Knowbury to the Parish Council from the Housing Association Connexus which was now being dealt with by the Solicitors acting for both parties. It is hopeful that the handover will be made on the 1st April 2020, but this will depend on the completion of the agreed footpath and road repairs.
- b) Notice Board Clee Hill Mr M Galbraith agreed to obtain the illustrative map which is to be placed in the Notice Board so that the Clerk could obtain the exact measurements and to look at the condition of the map.
- c) Speed Activated Sign Clee Hill The additional speed activated sign to be situated on a street-light column adjacent to Three Crosses Clee Hill should be installed before the end of January 2020.
- d) Police and Crime Commissioner –The Police and Crime Commissioner had agreed the 25% contribution towards the cost of the Smartwater kit which will be distributed free to each household within the Parish Area under the We Don't Buy Crime- Protected Village Project Smartwater Scheme.

The process of distribution will be discussed at the next meeting with consideration being given to a public event being held at the three village halls, Caynham, Knowbury and Clee Hill.

- e) Mrs H Jones had reported to Shropshire Council the Fly-tipping that had occurred along Caynham Road Knowbury.
- f) The Parish Council agreed to replace the broken white plastic bollards which bordered the amenity land on the road junction opposite Caynham Village Hall.
- g) The Clerk reported that the area to the rear of the toilets had been cleared and new fencing installed.
